
AEDC is pleased to present the second edition of the Anchorage Quarterly Economic Indicators Report for 2008. This report summarizes the most recently updated data contained in the Anchorage Economic Indicators Database. With this database, AEDC continually tracks and updates more than 25 different measures of economic activity in the Anchorage area.


Total Employment

- Total employment in Anchorage increased by 840 jobs between the second quarter of 2007 and the second quarter of 2008, an increase of 0.6 percent. On average, 152,400 workers were employed during the second quarter of 2008, based on Alaska Department of Labor and Workforce Development data.
- The largest increases in employment between the second quarter of 2007 and the second quarter of 2008 occurred in the government sector (270 new jobs) and the oil and gas sector (230 new jobs).

Building Permit Values

- Total building permit values, including residential, commercial and government construction, decreased from \$207.6 million in the second quarter of 2007 to \$160.9 million in the second quarter of 2008, a decrease of approximately 23 percent.
- Commercial building permit values decreased by 8 percent between the second quarter of 2007 and the second quarter of 2008, from \$110.4 million to \$101.5 million.
- Residential building permit values decreased by 20 percent between the second quarter of 2007 and the second quarter of 2008, from \$53.8 million to \$43.2 million.
- The value of construction permits for government projects decreased by 63 percent over the same period, from \$43.5 million to \$16.2 million.














Anchorage International Airport Traffic


- Total passenger deplanements grew by 3.7 percent between the second quarter of 2007 and the second quarter of 2008.
- The number of passenger aircraft landings increased by 4.9 percent between the second quarter of 2007 and the second quarter of 2008.
- The amount of transit cargo passing through Ted Stevens Anchorage International Airport decreased by 13.5 percent over the same period.



• Port of Anchorage annual tonnage for 2007 totaled 4.32 million short tons, a decrease of 0.7 percent since 2006.








Room Rental and Tax Receipts

- Gross room rental revenues increased by 8 percent between the first quarter of 2007 and the 1st quarter of 2008.
- Taxable room rental revenues increased by 6 percent between the first quarter of 2007 and the first quarter of 2008.
- Room tax receipts increased by 6 percent over the same time period.

• Car and RV rental receipts increased by 12 percent between the first quarter of 2007 and the first quarter of 2008.



Consumer Price Index

- The Anchorage Consumer Price Index increased from 179.4 in the first half of 2007 to 187.7 in the first half of 2008, an increase of 4.6 percent.
- The U.S. Consumer Price Index increased by 4.7 percent from 205.7 to 214.4 over the same time period.

Population

• The population of Anchorage increased from 283,244 in 2006 to 283,823 in 2007, an increase of 0.2 percent.
