This report summarizes the most recently updated data contained in the Anchorage Economic Indicators Database. With this database, AEDC continually tracks and updates more than 25 different measures of economic activity in the Anchorage area.

#### **Total Employment**

- Total employment in Anchorage increased by 900 jobs between the 1st quarter of 2007 and the 1st quarter of 2008, an increase of 0.6 percent. An average of 146,300 workers were employed during the 1st quarter of 2008, based on Alaska Department of Labor and Workforce Development data.
- The largest increases in employment between the 1st quarter of 2007 and the 1st quarter of 2008 occurred in the



professional and business services sector (330 new jobs) and the retail trade sector (200 new jobs).

#### **Building Permit Values**

• Total building permit values, including residential, commercial and government construction, decreased from \$138.0 million in the 1st quarter of 2007 to \$112.9 million in the 1st quarter of 2008, a decrease of approximately 18 percent.


- Commercial building permit values decreased by 7.4 percent between the 1st quarter of 2007 and the 1st quarter of 2008, from \$92.8 million to \$86.0 million.
- Residential building permit values decreased by 40.6 percent between the 1st quarter of 2007 and the 1st quarter of 2008, from \$32.5 million to \$19.3 million.
- The value of construction permits for government projects decreased by 39.7 percent over the same period, from \$12.6 million to \$7.6 million.



#### **Anchorage International Airport Traffic**

- Total passenger deplanements grew by 6.7 percent between the 1st quarter of 2007 and the 1st quarter of 2008.
- The number of passenger aircraft landings increased by 4.7 percent between the 1st quarter of 2007 and the 1st quarter of 2008.
- The amount of transit cargo passing through Ted Stevens Anchorage International Airport decreased by nine percent over the same period.

#### Port of Anchorage Annual Tonnage

 Port of Anchorage total annual tonnage for 2007 totaled 4.32 million tons, a decrease of 0.7 percent since 2006.

#### Room Rental and Tax Receipts\*

- Gross room rental revenues increased by 4.2 percent between the 4th quarter of 2006 and the 4th quarter of 2007.
- Taxable room rental revenues decreased by 0.8 percent between the 4th quarter of 2006 and the 4th quarter of 2007.
- Room tax receipts did not change between the 4th quarter of 2006 and the 4th quarter of 2007.

#### Car and RV Rental and Tax Receipts\*

- Car and RV rental receipts increased by 3.0 percent between the 4th quarter of 2006 and the 4th quarter of 2007.
- Car and RV rental tax receipts increased by 1.9 percent over the same period.

#### **Consumer Price Index**


• The Consumer Price Index increased from 177.3 in 2006 to 181.2 in 2007, an increase of 2.2 percent.

#### **Population**

• The population of Anchorage increased from 283,244 in 2006 to 283,823 in 2007, an increase of 0.2 percent.
