




Executive Summary

The year to date (YTD) non-seasonally adjusted unemployment rate in Anchorage is unchanged from July, averaging 5.9%. This is 0.5% lower than the 2011 YTD average. The monthly rate has gone down 0.4% from July, and 0.3% from August 2011. The monthly unemployment rate has dropped 0.2% since the beginning of the year. The increase of 627 in the employment total during the YTD period is primarily attributed to a reduction of 776 in the unemployment total, but also encompasses a 149 person decrease in the Anchorage labor force.

It is important to note that these unemployment numbers represent the labor force residing in Anchorage, and do not include jobs in Anchorage held by residents from outside the municipality. The industry employment estimates referenced in the remainder of this report are representative of all jobs in the Municipality of Anchorage, regardless of the job holder's place of residency.


As for the Anchorage Industry Employment estimates, the YTD average has maintained its upwards momentum and has a total increase of 1,650 over 2011 YTD. Industries showing the most improved YTD growth rates from July to August include construction and professional & business services. Eight of the ten major sector's August 2012 averages are above August 2011's, indicating sustained growth in many fields.



Overall, unemployment is averaging **5.9%** in Anchorage for the first 8 months of 2012, which is **0.5%** below 2011 for the same time.

Services Producing Jobs


Services producing jobs in Anchorage (engineering, retail, tourism, healthcare, etc.) totaled 143,600 for August. The total jobs increase from July to August this year is 800 jobs more than the same period last year and is showing a greater rate of increase than any of the previous three years. The educational and health services sector's growth rate continues to improve with a 2.47% YTD growth (+575 jobs). YTD job averages for many other service industries are also showing growth, including transportation (+288), professional & business services (+388) and food services (+300). The sector is still on track to maintain a 1% gain at the end of the year.



Health Care Employment


In January, AEDC predicted a growth for 2012 of 700 health care jobs. So far this year, the health care industry is averaging 488 more jobs than 2011's YTD. This is an increase of 2.85% jobs. This is below the 4.02% rate of growth needed to reach the AEDC's predicted mark by the end of the year.






Goods Producing Jobs


Goods producing jobs, which are construction work, mining and oil & gas production (those jobs that are specifically tied to production, not those which support the production or maintenance of the production jobs) are still growing, averaging 275 more jobs in 2012 YTD over the same period in 2011. Total construction jobs in August 2012 have reached 10,000 for the first time since August 2010 and are higher than August 2011's average by 300. If this year's monthly averages contract at a similar rate as 2011, the construction sector will see little to no change in the annual average. The Municipality of Anchorage is reporting new construction is up 10% for the YTD in the commercial and retail areas, which improves the chances of the construction sector maintaining its job gains.






Professional & Business Services

Jobs in this sector include those in engineering, architecture, legal services, accounting, scientific research, waste management and administrative services industries. The YTD average is up 388 jobs from 2011 and the sector's growth rate has increased by over a quarter percentage point since July. Job creation in this sector is more than twice the AEDC's January prediction of a gain of 150 jobs and shows no signs of contraction.







I 2,200 Transportation Jobs in August 2012

Transportation

August's preliminary estimate (12,200) continues this industry's strong year. The 288 increase in 2012 vs. 2011 YTD is well above the AEDC predicted growth of 100 jobs. Preliminary figures from the Alaska Travel Industry Association show an increase in summer visitors this year, which may be a factor in this growth.

Unemployment rate at 7.8 percent in August

Alaska's seasonally adjusted unemployment rate rose two-tenths of a percentage point in August to 7.8 percent. July's rate was revised down one-tenth of a percentage point to 7.6 percent. Alaska's rate has been climbing since June.

The comparable national rate was 8.1 percent in August, down two-tenths of a percentage point from July. The U.S. rate has been higher than Alaska's for 46 consecutive months, but August marks the narrowest gap since late 2007, when the U.S. rate crept above Alaska's for the first time since the early 1980s. Although the national rate has been inching downward, it has a long way to fall to reach pre-recession levels.


Seasonally adjusting Alaska's unemployment rate allows it to be compared with the national rate. Seasonal adjustment attempts to smooth out typical seasonal changes in the numbers so non-seasonal trends in the economy can be identified.

Alaska's not-seasonally adjusted rate was 6.6 percent in August, down from 7.2 percent in July. August typically has the lowest nonadjusted rate during the year, as summer activity reaches its peak. August's nonadjusted rate was down one-tenth of a percentage point from the previous year.

Alaska's not-seasonally adjusted high and low were rates both in the western part of the state. The lowest rate was in Bristol Bay Borough at 2.2 percent, and the highest was 22.5 percent in the Wade Hampton Census area.
