

# November 2012 Employment Report

### **EXECUTIVE SUMMARY**

### MONTHLY UNEMPLOYMENT

**The November unemployment rate for Anchorage was 4.9%**, the second month in a row that the rate has been below five percent. **This has not occurred since October-November of 2007** and is an indicator of a current healthy employment climate. The monthly rate went up 0.2 percent from the month prior but was down 0.5 percent from a year ago in November 2011.

#### YEAR-TO-DATE UNEMPLOYMENT


The average year-to-date (YTD) non-seasonally adjusted unemployment rate in Anchorage is down slighty from October, **averaging 5.6 percent.** This is 0.6 percent lower than the 2011 YTD average.

The increase of 188 in the employment total during the YTD period reflects a reduction of 922 in the reported unemployment total, which encompasses a 734 person decrease in the Anchorage labor force.


## ANCHORAGE INDUSTRY EMPLOYMENT ESTIMATES

The YTD average for the Anchorage industry employment estimates has maintained upwards momentum with a **total increase of 1,691 jobs** over 2011 YTD. **Industries showing the most improved YTD growth rates from October to November include educational and health services** and **professional and business services**.

Eight of the 10 major sector's November 2012 averages are at or above November 2011s, indicating sustained growth in many fields.



It is important to note that these unemployment numbers represent the labor force residing in Anchorage, and do not include jobs in Anchorage held by residents from outside the Municipality. The industry employment estimates referenced in the remainder of this report are representative of all jobs in the Municipality of Anchorage, regardless of the job holder's place of residency.




Services producing jobs in Anchorage totaled 143,500 for November: Overall, the YTD average is up 1,373 jobs from 2011 YTD, and is expected to stay at a similar level through the end of the year. The educational and health services sector's


Increase of Services Producing lobs YTD in 2012 vs. 2011

growth rate continues to improve with a 3.35 percent YTD growth (+782 jobs).YTD job averages for many other service industries are also

staying positive, including transportation (+227), professional & business services (+518) and food services (+309). The services sector looks to be on track for a yearly increase of roughly I percent in total jobs by the end of the year.








### GOODS PRODUCING JOBS CONSTRUCTION WORK, MINING, OIL & **GAS PRODUCTION**

Goods producing jobs (does not include jobs which support the production or maintenance of production jobs) are still growing YTD, averaging 309 more jobs in 2012 over the same period

in 2011. The oil and gas and manufacturing sectors




are continuing to show strong positive growth with YTD Manufacturing increases of 3.88 percent and 10.19 percent, respectively.

Total Anchorage construction jobs in November 2012 are higher than November 2011's count by 100. Local capital investment projects connected with the city's growing retail

sector and the renovation of existing buildings (such as the new NANA offices, the Hotel Captain Cook and the Northway Mall) have helped to maintain the job numbers throughout the year.

Given the current employment trends in this sector, it is highly likely that the year-end result will show either a flat or a slightly positive growth rate for construction related jobs. Compared with the 12.76 percent reduction in construction jobs statewide, this sector's job numbers should be seen as a positive indicator of the local economy.



### HEALTH CARE EMPLOYMENT

In January 2012, AEDC predicted a growth of 700 health care jobs during 2012. Through November 2012 the **health care industry is averaging 509 more jobs** than 2011's YTD, for a **2.96 percent increase**. This is below the 4.02 percent rate of growth needed to reach the AEDC's predicted mark by the end of the year, and is also lagging behind the national average of 3.3 percent growth. Current employment trends indicate a

trends indicate a continuation of this rate of growth through the end of the year.

Healthcare jobs YTD in 2012 vs. 2011





The YTD average is **up 518 jobs from 2011** and the rate of increase has been steadily rising by at least 0.2 percent each month since July. Job creation in this sector is **more than 3X AEDC's January prediction** of a gain of

### TRANSPORTATION

November's estimate of 11,200 transportation industry jobs continues to illustrate what a strong year this sector has had. The **227 job increase** in 2012 versus 2011 YTD is well above the AEDC predicted growth of 100 jobs. Recently, cargo carriers utilizing the Ted Stevens Anchorage International Airport (TSAIA) paid for an expansion of the facility's fuel system, something the TSAIA Airport Manager John Parrott points to as a positive indicator for

a continuation of the current level of commercial activities for the foreseeable future.

Transportation Jobs YTD in 2012 vs. 2011






### **Unemployment rate at 6.8 percent in November**


Alaska's seasonally adjusted unemployment rate fell three-tenths of a percentage point in November to 6.8 percent. The comparable national rate was 7.7 percent, down from 7.9 percent in October.

Alaska's November decrease marks the third straight month of lower rates since August. Recent declines have returned the rate close to what it was before summer, and brought it slightly below the state's 10-year average. The national rate remains just over a percentage point above its average over the same period.

Alaska's not-seasonally adjusted rate in November was 6.6 percent, up from October's revised rate of 5.9 percent. Increases in the unadjusted rate are normal this time of year, after the end of summer employment.

The highest and lowest November rates for Alaska's boroughs and census areas — which are not seasonally adjusted — were both in Southeast. Juneau's rate was lowest at 4.7 percent. Skagway, which largely depends on summer tourism, was highest at 22.0 percent.
